The Foundation contributed \$4,850 to a committee which is actively engaged in supporting a ballot measure to provide sales tax to support the Stanislaus County Free Library. No funds have been provided to support any political candidate. No other direct or indirect political activities were engaged in during 2010.

Since the sole purpose of the Foundation is to support the Library, this was considered an appropriate action.

Funds advance equal less than 20% of funds disbursed in 2010.

Form 5768 was filed in 2010 in anticipation of supporting this ballot measure.
