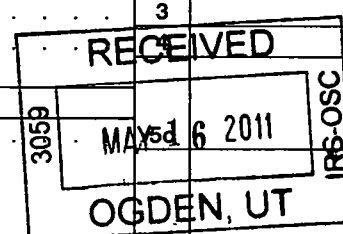

RESPONSE TO FACTS AND CIRCUMSTANCES TEST TO QUALIFY AS A PUBLICALLY SUPPORTED ORGANIZATION

ACE Public School Network's (ACEPSN) mission is public education reform in traditionally

underserved neighborhoods San Jose, California. ACEPSN has successfully created

three small, autonomous schools within the Alum Rock Union School District, plus one similar

school in the Franklin McKinley School District. In addition, ACEPSN founded a public charter

school, which has since moved into a separate corporate entity due to requirements from its charter authorizer.

ACEPSN's mission appealed to a number of affluent individuals and corporations in nearby Silicon

Valley Communities. Their donations tended to be very generous, and thus skewed the percentage

of contributions greater than 2%. However, these individuals and organizations all shared ACEPSN's

passion for public education reform. It should be noted that 2010 was a quiet year for ACEPSN.

While work continued with school districts in the San Jose metro area, donations faltered given the

bad economic climate, so resources were limited. However, the prospects remain good for a

resurgence of ACEPSN, and it firmly believed that it meets the test of a Publically Supported

Organization.
