TRUST AMENDMENT

BACKGROUND

1. WHEREAS, on February 9, 2007, STEPHEN M. MCDONNELL and JILL K. MCDONNELL, as Settlers and initial Trustees, entered into an Agreement of Trust known as "The Stephen and Jill Kearney McDonnell Family Foundation" (the "Trust"); and

2. WHEREAS, by Amendment dated October 29, 2007, the Trust was amended to change the name of the Trust to "THE ORGANIC SCHOOLHOUSE"; and

3. WHEREAS, pursuant to SECTION SIXTH, PARAGRAPH A of the Trust, Trustees shall have the right to amend the Trust at any time and from time to time, provided that (i) no such amendment shall cause the Trust to cease to be an organization described in Section 501(c)(3) of the Internal Revenue Code; (2) STEPHEN M. MCDONNELL and JILL K. MCDONNELL, or the survivor, shall have the sole power to amend the Trust while they are Trustees thereunder; and (3) in the event that STEPHEN M. MCDONNELL and JILL K. MCDONNELL, or the survivor, are no longer Trustees thereunder, SECTION SECOND, PARAGRAPH B, may not be amended; and

4. WHEREAS, Trustees desire to exercise the authority granted to them in SECTION SIXTH, PARAGRAPH A of the Trust and amend the Trust by revoking SECTION THIRD thereof and by substituting the following SECTION THIRD in its place:

"SECTION THIRD

Trustees

A. Number and Eligibility. There shall be no less than Two (2) nor more than Seven (7) Trustees hereunder. STEPHEN M. MCDONNELL and JILL K. MCDONNELL, or the survivor, shall have the sole power to appoint additional Trustees, fill vacancies and determine the terms to be served while they are Trustees hereunder and each shall have the power to designate their respective successor or successors as Trustees hereunder. When neither STEPHEN M. MCDONNELL nor JILL K. MCDONNELL are serving as a Trustee, a majority of the remaining Trustees shall have the power to appoint additional Trustees, fill vacancies and determine the terms to be served. Upon attaining the age of Eighteen (18) years, each of NORA AIMEE MCDONNELL, KEARNEY GREENLEAF MCDONNELL and FLANNERY AGNES MCDONNELL shall serve as additional Trustees hereunder. If both STEPHEN M. MCDONNELL and JILL K. MCDONNELL shall fail or be unable to serve as Trustees and any of NORA AIMEE MCDONNELL, KEARNEY GREENLEAF MCDONNELL and FLANNERY AGNES MCDONNELL shall not have attained the age of Eighteen (18) years, then ANNA MCDONNELL HARPER shall serve as Trustee until such time as NORA AIMEE MCDONNELL, KEARNEY GREENLEAF MCDONNELL and FLANNERY AGNES MCDONNELL are serving as Trustees.

B. **Appointment.** Any appointment of a Trustee shall be made by a written instrument delivered to the person to be appointed.

C. **Resignation.** Any Trustee hereunder may resign at any time for any reason without need for court approval by written instrument delivered to the other Trustees and filed with the Foundation records.

D. **Removal.** No individual Trustee may be removed from office, except that STEPHEN M. MCDONNELL and JILL K. MCDONNELL, or the survivor, while they are Trustees hereunder, shall have the power to remove another Trustee from office with or without cause by written instrument delivered to the Trustee to be removed.

E. **Compensation.** Trustees shall be entitled to reasonable compensation for services rendered to the Foundation and to reimbursement for their reasonable expenses incurred in connection with the administration of the Foundation. Corporate Trustees may, at the discretion of the individual Trustees, be compensated for their services.

F. **Voting.** STEPHEN M. MCDONNELL and JILL K. MCDONNELL shall each have eight votes while serving as a Trustee hereunder. Each additional or successor Trustee shall have one vote. Except as provided in Subsections A and D of this SECTION THIRD and Subsections P and Q of SECTION FOURTH, the Trustees empowered to act with respect to any matter shall act by majority vote.

G. **Accountings – Releases.** Trustees shall not be required to file annual or other periodic accountings notwithstanding any statute or rule of Court to the contrary. Upon the death of any Trustee, the remaining Trustee or Trustees may release the estate of the deceased Trustee from any liability relating to the Foundation.

H. **Bond.** Trustees shall not be required to post bond or enter security in any jurisdiction.

I. **Managing Trustee.** In accordance with the authority contained in Subsection P of SECTION FOURTH, the Trustees designate JILL K. MCDONNELL as the initial Managing Trustee of this Trust.

J. **Corporate Trustee.** Notwithstanding anything contained in this SECTION THIRD to the contrary, individual Trustees may appoint a Corporate Trustee qualified to so act to serve with them as Trustee hereunder and may remove any such Corporate Trustee from office with or without cause, except that STEPHEN M. MCDONNELL and JILL K. MCDONNELL, or the survivor, shall have the sole power to appoint and remove a Corporate Trustee while they are Trustees hereunder. A Corporate Trustee's powers shall be subject to the provisions of Subsection Q of SECTION FOURTH."

5. WHEREAS, Trustees further desire to exercise the authority granted to them in SECTION SIXTH, PARAGRAPH A of the Trust and amend the Trust by addition the following paragraphs C and D to SECTION SECOND of the Trust:

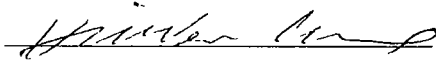
"C. **Priority of Distributions.** If neither STEPHEN M. MCDONNELL nor JILL K. MCDONNELL is serving as a Trustee hereunder, Thirty-five percent (35%) of distributions made from the Trust shall be made to organizations which promote health and wellness, so long each such organization is exempt from Federal income tax as an organization described in Section 501(c)(3) of the Code.

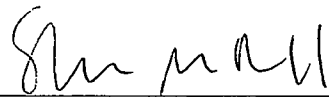
D. **Limitation on Distributions.** If neither STEPHEN M. MCDONNELL nor JILL K. MCDONNELL is serving as a Trustee hereunder, no distribution of Fifty Thousand Dollars (\$50,000) in any given year or more shall be made by Trustees to any organization unless the Trustee recommending the distribution is actively involved in such organization."

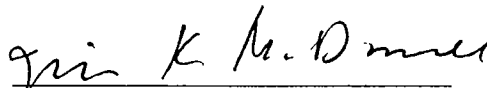
