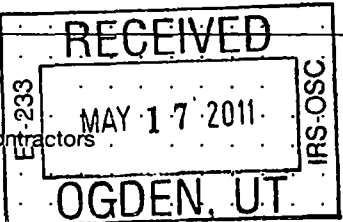

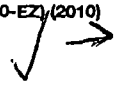

Other expenses - \$4887 used in the development of curriculum materials by the workers required the workers to purchase of books, pictures, and other materials from mail order catalogs. Since the Foundation had no Credit Cards the workers would purchase with their own Credit Cards and then Invoice the Foundation for repayment. This was the best expedient for the Foundation to handle the purchases.

Part III Section 31 - Other Services- The foundation develops research on books and other resources for Patrons of the museums and historical societies and speakers to other assemblies. Through activities such as these the Foundation is able to better communicate with others in line with the Foundation's mission.
