Description of Achievements for 2010

Quantitatively in 2010, ROP's programs experienced increase and decrease. The biggest increases were, of course, in our two new programs.

In September, Youth Ministries initiated a program focused solely on middle school students. The middle school program meets once a week and initially partnered with both the Boy Scouts - who provided life-skill teaching once a month - and Moorhead Recreation Center (city of Aurora) which provides facility space twice a month. In early 2011, the Boy Scouts withdrew due to a scheduling conflict, but we hope that partnership will soon be rekindled. The middle school program started modestly with the participation of 12 kids.

ROP's English as a Second Language (ESL) program also started in September 2010. Clearly there is a great felt need for assistance in learning English in our community as evidenced by the 68 different students that participated in our first month. By year-end attendance declined to 56, but most of these students are coming each of the three days per week that ESL classes are offered. As with all ROP programs, our ESL classes are free and open to anyone who wants to participate, but it is also worth noting that much of the material used to practice English comes from the Bible.

Among ROP's existing programs, we saw the most growth in our GED program where the average number of students attending each month more than doubled from 9 in 2009 to 19 in 2010. From the total of 37 students that participated during the year, 18 tests were taken, 15 were passed and two students completed their GED. (Students must pass 5 separate tests to receive their GED.) The GED program continues to gain momentum with 4 students already receiving their GED in the first quarter of 2011. We also saw increases in the number of counselees (from 16 to 23) and 12-step participants (from 6 to 11). On the other hand, ROP's food bank experienced about a 12% decrease in the number of households served (from 5,168 to 4,535) and a 15% decrease in the lbs. of food distributed (from 160,904 to 136,784). The reasons for the decline are unclear, but at least one reason may be the opening of another food bank in our area for which we are grateful.

During 2010, Resources Ministries also hosted 8 large community outreaches. These outreaches increase our visibility within our community, provide holiday related food/and or other practical needs and give us an opportunity to present the Gospel. We are thankful for the many churches that partner with us to make these outreaches possible. Through our 2010 community outreaches, ROP provided back packs filled with school supplies to over 700 children; sponsored 70 families to receive Christmas gifts for their children; and served meals to almost 2800 people.

On the Youth Ministries side of ROP, we saw both growth and decline in the numbers of participants in our existing programs. Our Club House program for elementary school kids grew significantly from average monthly participation of 29 in 2009 to 48 in 2010. On the other hand, participation in our Coffee House program for teens declined slightly from a monthly average of 16 in 2009 to 14 in 2010. Despite the

decline in participation, we saw significant growth in the maturity and character of our core group of teens, several of whom are serving regularly in our Club House program and other ROP ministries.

Most significantly, during 2010 we saw 62 adults and 21 children make a decision to follow Jesus Christ as their Lord and Savior. We say this is "most significant" because of our conviction that lasting life change only comes through a growing relationship with our creator. However, anyone observing ROP at work would observe that all of our services are offered unconditionally to all who come regardless of race, religion or sexual orientation. We seek to show God's love to all the people who come to our doors for help in any way we can. Usually, this involves providing practical assistance with food, clothing, tutoring, mentoring, counseling or other training, but we also seek the opportunities God gives us to share His love in word as well as deed with those interested in learning more about the God who loves them.
