Emergency Earthquake relief. In April 2010, 1 devastating earthquake struck the ethnically Tibetan region of Qinghai province, China where the foundation has already nbeen providing support for educational and other charitable activities. Approximately three thousand people were killed and twenty thousand injured in the city of Jyekundo (Yushu), the closest city to Surmang monastery. Monks from the Surmang monastery rushed to the city to help with disaster relief and aid distribution. Funds were provided to the monks to use for the purpose of tons of emergency food and clothing for the earthquake victims and also to distribute as direct financial aid to many hundreds of low income families in the city among thousands who were left homeless by the earthquake.

School construction. 2010 represented the seventh year of a construction program for a 25,000 square foot school complex (shedra) in the remote, very low income, Surmang valley, in an ethnically Tibetan region of Qinghai province, China. The rate of illiteracy in the area is reported to be over 90%. The school is locally managed and administered. This was a significant year for the complex because portions of the complex were completed and were used for the first time. Construction included some masonry and other detail work, flooring, paving of the courtyard & detailed painting of the entire complex. Most of the painting was done by a contractor who employed approximately thirty low income Tibetans from a neighboring region.

Educational program. After pilot programs in off-site locations, the first classes were held in the new Surmang building complex. More than 100 very low income local children began participating in the fall of 2010, receiving basic education. At least one meal per day was served to participating children, who ranged in age from 5-15.
