Part III Statement of Program Service Accomplishment

What is the organization's primary exempt purpose?

To create a strong, sustainable and results-focused community partnership with the goal of improving each individual's success in school, college and career within Bexar County. Ensure that all students are college and workforce ready upon graduation from high school.

Part III Line 28

P16Plus continues to partner with 15 local school districts and provides a management data analysis tool for assistance in planning and measuring progress in academic and financial areas. District personnel continue to be trained on the effective use of the tool and participating school districts partner with peer districts throughout the state of Texas to share knowledge of best practices and to improve their academic and financial performance.

Four Workgroups Activities:

Workgroup One – The goal of this group is to ensure that all infants and children are prepared to succeed. A report was made to the Council and reviewed by a third-party organization for feedback. The reviewer reported to the Council on the two suggested pilot programs. At this time both are on hold due to economic pressures in the community. The workgroup has documented several best practices and those best practices will be highlighted on the P16Plus website in 2011. Further implementation will be considered as the P16Plus Council completes a 3-year strategic plan in 2011.

Workgroup Two – This group focused on how to prepare, retain and develop highly qualified teachers. They have researched best practices in classroom management, conflict resolution, and teacher coaching/mentoring. The group recommended collaboration on San Antonio Math & Science Education Coalition and supporting a Trinity University and San Antonio Independent School District Science/Math Partnership which were approved and acted upon. The third recommendation was to implement a Dr. Parker Palmer teachers' facilitation certification conference and offer it to local school districts, colleges and universities. The conference will be held in 2011.

Workgroup Three – The goal of this group is to promote a college going culture in Bexar County within one generation. To accomplish the 15-year sustainable initiative, it was decided by the Council to work with the Texas Higher Education Coordinating Board on

their Generation Texas program. After much deliberation and study, it was decided to spin off this goal to a stand alone nonprofit named Generation Texas San Antonio. In the interim to receiving the approval of the new organization, P16Plus has continued to work on implementing the media/marketing/messaging campaign, continue with the creation of classroom curriculum with a college going message components and identify college and career related resources that could be utilized by students of all ages.

Workgroup Four – The goal is to develop an expectation of career and lifelong learning for all citizens. The workgroup visited college and universities with programs that provide specific career-focused training curriculum for certification courses, continuing education for adults, and reviewed samples of nationally recognized curriculum. A report has been issued and the recommendations will be presented to the Council in 2011.
