

The purpose of the Lane County DUII Victim Impact Panel (VIP) is to educate court-mandated offenders arrested for "driving under the influence of intoxicants" (DUII) about the impact their behavior has on other individuals in the community. Victims of drunk-driving accidents and family members (all volunteers), law enforcement and hospital personnel, and others affected by an individual's drunk driving are utilized to present the monthly panels to offenders. In 2010, 2,578 offenders attended the program. They are required to listen to the volunteer speakers, watch video presentations, and learn about making healthier choices re: drinking and driving. The fee revenue pays administrative expenses and allows the program to support other organizations with like-minded goals.
