home care, prevention of disease including HIV/AIDS. In 2010, NCF came alongside and provided support to the Community Health Evangelism program LifeWind in Gedeo region of Ethiopia. Approximately 500,000 people have been trained in improving health education with the result that malnutrition rates and infant mortality rates have dropped by 50% with those people.

3) Education: This Initiative is designed to empower communities by promoting literacy, training teachers, building an educational infrastructure, and providing basic education in the areas of business and health. To-date, tuition for seven nursing students has been provided.

4) Assistance: The "Assistance Initiative" looks directly at the needs of deeply disadvantaged people. NCF seeks to move beyond a handout -based approach-the unique needs of widows, orphans and the homeless call for unique solutions. NCF contributed to the support for Christian World Adoption orphanage in Soddo, Ethiopia in 2010. The orphanage cares for 20-30 abandoned infants and pre-schoolers who are candidates for foreign adoption.

NCF contributed support for the El Shadai food distribution program in Soddo. This program provides grain for some of the neediest people.

5) Financial: NCF's "Finance Initiative" is designed to provide short-term financial assistance to Ethiopia through a variety of loan programs and partnerships with individuals and organizations. To-date this includes a loan to local coffee businessmen and farmers to purchase a coffee washing plant and funding to begin a food production facility
