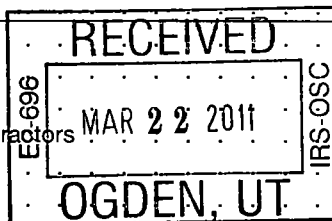

Statement of Program Service Accomplishments

Mmametlhake Family Care Center

After seven years of existence, the Mmametlhake Family Care Centre continues making a large contribution in the South African fight to eradicate HIV/AIDS. The Centre's Home Based Care Workers and Counsellors ended 2010 with 388 clients, all impacted by the pandemic. Among these, their families/caregivers, tradition leaders and Government and the populace, the Centre has huge credibility. The Centre is involved in various types of HIV/AIDS education in schools and communities with a population base of approximately 250,000. During the 2010 World Cup, the Centre sponsored large HIV/AIDs rallies educating and challenging youth and adults to make wise choices.
