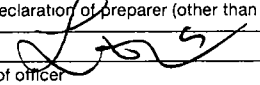

Placement of children: 580 orphaned children (up to fourteen years of age) from the People's Republic of China and Haiti were placed with American adoptive families in 2010. An additional 300 families had applied and were in various adoption stages (including application, orientation, home study, compilation of adoption dossier, translation, waiting to be matched with a child by the Chinese/Haitian government, traveling, court validation of adoption, post adoption supervision and family support). At 12/31/10, 1,850 families were at various stages of the adoption process.

4b (Code:) (Expenses \$ 700,550, including grants of \$) (Revenue \$ 647,964)

Chinese Children Charity Fund: A restricted fund dedicated to humanitarian assistance to orphanages. The fund has been used to purchase food and clothing, educational materials, toys and medical intervention for orphans. CCC has also developed six orphan care centers in Zhejiang, Hunan, Chongqing, Luohe, Zhengzhou and Kaifeng, Henan which care for 200+ children. As a special project, CCC set up a foster sponsorship program for children who are under the age of 13 to live with foster families in China. This program has been set up to assure that the children's needs are being met before they are adopted, as well as for the children who will not be adopted. In 2010, CCC sponsored 500+ foster care children.

4c (Code:) (Expenses \$ 331,625, including grants of \$) (Revenue \$ 231,828)

Family development services: In order to ensure the success of adoption placements, CCC has developed post-adoption services designed to assist family understanding and bonding. A Chinese culture oriented parent-toddler/preschooler/kindergarten/elementary program continues called the Joyous Chinese Culture Center with the goal of overcoming some of the issues faced in cross-cultural, interracial adoptions. More than 300 children and their families have participated in these activities, which continue to be expanded.
