They charge a fee per team that is entered into the league. They use these fees to pay expenses such as referees, officials, umpires, game fields, gym space for games, as well as their administrative fees to schedule thousands of games per year.

League Fees/Lacrosse - This expense is paid directly to US Lacrosse for the registration of our players and coaches. It is required to play lacrosse that each participant be a member. It provides training and insurance to players and coaches.

Field Use/Setup - These expenses are incurred for renting the fields from local schools, recreation centers, parks and recreation districts and cities.
