Organization's primary exempt purpose:

The Tibetan Children's Education Foundation is a nonprofit corporation founded in 1995 and dedicated to the preservation of Tibetan culture by supporting Tibetan schools and school children in exile from their homeland.

Description of Achievements in Carrying Organization's Exempt Purpose:

Cultural Tour 2010

One of the major aims of our Foundation is to help preserve Tibetan culture by raising awareness of this unique culture here in the West. The Sand Mandala Tour of 2009 was very well received and we followed up on that success by organizing a similar tour this year. This year we focused our tour in the state of Montana with most of the events being organized in the bigger towns here in Montana. The tour started with the Sand Mandala Creation being one of the events at the National Folk Festival at Butte, Montana. This was followed by Sand Mandala Creation events at Helena, Billings, Bozeman and Great Falls, MT. We did two more events - one in Jackson, WY and another at Bismarck, ND. At each venue, besides creating the sand mandala, Ven. Ngawang Chojor (the master Tibetan sand mandala creator) gave presentations on this unique art form. The Sand Mandala events also gave the foundation great platforms to talk about the Tibetan culture and to find support for the education of Tibetan children in exile.

Major expenses for the tour included artist's fee and travel, boarding, lodging for the sand mandala artists and accompanying staff during the tour. Major income from the tour came from donations to our general fund and funds for the sponsorship programs.

Children's Sponsorship Programs

Kyitsel-ling Sponsorship Program: Individual sponsors contribute \$25 to \$45 a month to support the education of needy Tibetan children staying at Kyitsel-ling Tibetan Children's Education Center in India. Kyitsel-ling provides boarding, lodging and meets all school related expenses with this sponsorship money.

Kyitsel-ling Outreach Sponsorship Program: Individual sponsors contribute \$25 to \$45 a month to support the education of needy Tibetan children outside Kyitsel-ling that are supervised by Kyitsel-ling.

College Sponsorship Program: Many of the children who received their school education through our sponsorship program are now graduating high school. The TCEF Board decided to make efforts to support the college education of the brightest of these. We made a small beginning in

2008 by sponsoring the education of one child in college. The beneficiary of this sponsorship was again selected by a selection committee headed by the Director of Kyitsel-ling Tibetan Children's Education Center, N. India on the basis of merit and need. The sponsorship is worth \$1,000 per year and 100% of it goes directly to the selected student.

Grandparent's Fund

Living stipends for Elderly: This is an effort to help elderly Tibetans living in exile (mostly in India) in need - those who are sick, those with no children or other family members to provide for them, etc. Individual sponsors contribute \$20 to \$30 a month to support these elders in need.

Other Programs:

Lunch Program, Yuksom Sikkim

Dubdi Monastic School is located in Yuksom Village western Sikkim, India. TCEF began a lunch program for this small monastic school in 2008. There are between 24 -30 young monks from very poor families receiving their education here. This monastic school is a one room schoolhouse with no electric and no heat. There are few books that are shared between all the children and each child has only one thin notebook and they use their pencils down to tiny stubs. The lunch project for the monks in Yuksom continued in 2010.

Kyitsel-ling Kitchen Remodel Project

The kitchen at Kyitsel-ling Tibetan Children's Education Center, Clement Town, N. India was built in 1998. It was then planned to serve fifty children. Now there are around one hundred children. This program is aimed at expanding and remodeling the kitchen so that it can service one hundred children at the center.

Zuluk Hostel Building Project

Zuluk is a remote area in the Indian state of Sikkim. The residents of this village are very poor and mostly illiterate. Lama Paljor - our local partner here has made an effort to help educate the children in this area. He has already founded a small hostel where children from the remote areas are housed, provided with supplementary education and sent to nearby schools. The hostel had only two major rooms - a boys' dorm and a girls' dorm - and there was a great need to add one more room - a multipurpose room for the children to study and eat. This year TCEF helped to get half of the funds needed for this project.

Zuluk - Bedding for the Children Project

The TCEF service team that visited Zuluk in 2009 identified a need to improve the bedding of the children in the hostel. We succeeded in 2010 by getting the required funding (\$1,800.00) to provide the children with a set of new beddings!

Yushu Earthquake Relief

In March 2010, a massive earthquake devastated the region of Yushu in Tibet. Various organizations were involved in providing relief to the affected people - mostly nomadic Tibetans in that area. TCEF organized a fundraiser and the proceeds of that event were sent to help the affected people.

Service Programs in India

TCEF staff and Board members take groups of interested persons to program sites in India. The service group does various projects like exchange projects, photo projects, construction projects, music, English Literacy and World Culture presentations.
