



INFORMATION SHARING REGARDING COMMON ISSUES OF THE MEMBERS INCLUDING INTERPRETATION OF THE LATEST WATER COURT RULINGS. CONDUCT RESEARCH AND ADVOCACY ON BEHALF OF THE MEMBER DITCH AND RESERVOIR COMPANIES. LIMITED EFFORTS TO PROMOTE ENACTMENT OF LAWS THAT ADVANCE THE MEMBERS' COMMON INTEREST. WILL NOT PARTICIPATE IN ANY CAMPAIGN FOR OR AGAINST ANY PARTICULAR CANDIDATES OR TRY TO INFLUENCE ANY EXECUTIVE BRANCH.
