### Statement of Program Service Accomplishments

Another amazing year has come to an end! We extend our sincere thanks and appreciation for those who have helped us at UnbridledACTS ministries at the Doud House --- also for your time, prayer and financial support.

God's flow continues to move through the house with healing, restoration and transformation. After nearly two years of a full house, we experienced the joys and sadness of having our guests' transition out. Suzi and Carolina moved out in May and Chrissy moved out in September of this past year. It's a touching thing to journey with each divinely selected individual God has chosen to connect our paths in deep relationship with. We often hear, "what a great thing you are doing -- isn't it difficult?", but the truth of the matter is that we feel so incredibly blessed to be on this journey. We feel like we are living in the center of His calling for our lives. Sure there are difficult moments, but to see God's hand in transforming the broken-hearted and to see his love poured out in real life experiences is so beautiful. It literally nourishes our souls and deepens our love for our ABBA Father. So please join us in rejoicing that He is an active loving God who wants the absolute best for His children -- us -- yes, you and me.

We were blessed to have a new member join us in September. We have so much hope for her and cannot wait to see her rise up - restored and transformed. I wish it was appropriate to share her story because then you would understand how she will, someday soon, be a true kingdom warrior. She is wonderful, beautiful, and amazing and she teaches us the heart of God almost everyday with her child-like faith. The following are her words:

*"From Lonna and Company... I thank God and UnbridledACTS for providing me a safe place to live while I heal from the trauma of my past. Moving from another state, in order to work with a Godly, experienced doctor- and -wife team has been more than I ever hoped and prayed for. You have made that possible."*

When KC, a former guest, came to stay for a weekend saw that we were writing this letter, she asked us to include some of her experiences:

*"When I came to UnbridledACTS I was a scared, drugged, hurt, party girl. I grew up in foster care and that was only the start of the trauma I went through. I was pregnant and alone, with no one to turn to. When I came in for the initial interview I remember a feeling of great relief - almost like the Holy Spirit was in the ACTS House. Troubled, I struggled to find my way out of the darkness. Through time I found myself able to cry and release my emotions in a healthy and positive way. I let my walls fall and let love in. My daughter, Trinity, is now a healthy and beautiful one year old baby girl. I don't think I would have ever been able to become the mother I am now without UnbridledACTS. Thank you to all who support this ministry."*

The year 2010 was an incredible year of growth -- spiritually, emotionally and relationally in both ministry and business. One of the things we learned was how God is truly our provider, just like His word promises. For the past two years we had sustained significant losses in the Companies who support the ministry of UnbridledACTS. And, like many others we lived on the edge of bankruptcy having to rifle through our 401K savings, the kids' college funds and credit cards. I'm sure many of you understand this. We were literally crying out to God for provision.

In February 2010, I (Stan) started to feel prompted to purchase the majorities shareholders (51%) stake in Unbridled Solutions. With bad credit, still sustaining business losses and a poor debt to

equity ratio – well – you can just imagine what the banks had to say, “NO WAY.” Then, on June 24<sup>th</sup>, my birthday of all days, I woke up and told Cindy today is the day I’m to press for a separation with our partners – an irrevocable buy/sell agreement one way or the other. So without any money we sent a letter to our partners saying we needed to separate. We worked out a price that either party would accept and within 90 days – September 30 – the deal was done. And no, there was no money from banks involved. God literally brought the funding in from a source that no one could have ever expected. It’s a story unto itself that is worth explaining at a different time. So in God like fashion, Unbridled Solution’s annual revenues for 2010 grew 45% (in the last 90 days) returning us back to profitability and contributing much needed funding to UnbridledACTS. It really is a miracle and we believe the increase will continue for His glory.

During the year God also began to lay on our hearts and the hearts of those closest to the ministry, His vision for expansion here in Elizabeth and in Africa. While the plan is still unfolding, we believe He is asking us to add, to the existing community, a second home and a green house on the adjacent three acre lot next door. The purpose of this home would be to serve youth in crisis.

We also formed a new partnership which extends UnbridledACTS influence to Africa. The genesis of this partnership began in January 2010 when God called Beverly Harris to join a ministry team traveling to Uganda. While there the team met a Ugandan pastor who had started a ministry to help train and teach pastors to spread the Gospel throughout Africa. The ministry also focused on helping widows and orphans as stated in James 1:27. His vision and focus fit nicely with the original vision of UnbridledACTS. Following the mission trip, that pastor, with the very appropriate first name of Sunday, began contacting us and a friendship was begun.

As this relationship grew and matured spiritually, God began a very clear calling to Bev and Dave Harris (UnbridledACTS Board Members) toward Africa and the work that Sunday had begun. In early November, we traveled with Bev to London, England and met with Pastor Sunday to discuss God’s leading in this partnership. As we talked and prayed, God made it abundantly clear that we were to move forward. We are not sure of all of the details, but God is faithful and will reveal a step at a time.

In closing, we want to encourage you to believe the Gospel in its divine entirety. God has such an amazing journey for each and every one of His children if we will just enter in. His love will not run shy or disappoint. We love you all very much and thank you for all your prayers and support
