The Native Science Field Centers (NSFC) offer year-round environmental science field programs that integrate
traditional ways of knowing, Native language and Western science methods. There are
three Native Science Field Centers, one on the Blackfeet Reservation in collaboration with Blackfeet
District No. 21, and one on the Pine Ridge Reservation in collaboration with Oglala Lakota College.
A local director and Community Advisory Board administer each Center. The NSFCs engage youth and adults
in outdoor science and cultural programs to encourage their long-term involvement with
their environment. The NSFCs are made possible with generous support from the National Science
Foundation and the Bush Foundation.
3,000 youth and adults were served in this program.

Youth Leaders in Service provides training and support to youth program leaders
that engage rural and tribal youth, ages 11-17, living in Montana, Wyoming, and
South Dakota's Pine Ridge Reservation, in leading service-learning activities that
create healthier communities. Adults work with youth to determine meaningful
community service projects, provide training and reflect on the process, support
the recruitment of additional adult volunteers, and manage grant funds and documentation.
Youth, with service-learning adult mentors, design and implement innovative service projects with local community
partners that improve their community and build their civic engagement, academic, leadership and community
problem solving skills. Youth Leaders in Service is made possible through Learn and
Serve America, a program of the Corporation for National and Community Service.

Hopa Mountain's StoryMakers program is an early learning initiative that offers parents of children
ages 0-5 proven tools to support them in creating a home environment that gives
their children the best chances for success in school. Through community
teams of citizen leaders, the StoryMakers program offers: high-quality, age
and culturally appropriate, children's books as tools to enhance children's social,
emotional and cognitive development; current parent-friendly child development
information and book-sharing ideas; personal encouragement to shape home life for children's
success with relationships and learning. This program has helped approximately 8,000 participants.
