WESST's key services, offered at six regional offices, include microenterprise, small business and financial literacy training, technical assistance, business incubation and access to capital through its revolving loan fund. The WESST Enterprise Center, a LEED-Certified Small Business Incubator, opened in January 2009. Through the benefits of a comprehensive business assistance program and guidance from advisors and mentors, members can accelerate the growth of their companies.

Financial Assistance: In 2010, WESST extended 48 loans totaling \$737,231 through its Microloan Revolving Loan Fund. In addition, statewide staff work with start-up and existing business owners to help them access capital through other sources.
