Village Resident Financial Assistance - The Village abates part or all of the monthly expense assessment paid by the residents who suffer from depleted financial assets. The Foundation provides a supplemental monthly stipend to cover incidental living expenses of those persons who qualify for such abatements. The Village administers the program and the Foundation disburses the funds monthly.

Medical Equipment - From time to time needs for medical equipment arise for the Health Center which exceed the Village's budget for the current year. After due consideration of a request for funding from the Village to allow purchase of specific equipment, a committee of the Foundation will recommend what action the board of the Foundation should take on the request. The major requests during 2009 included 2 scales, view finder and 4 long beds.
