3RD CROP INITIATIVE is an effort to improve water quality in local rivers and lakes by diversifying the current agricultural cropping system. In our region the main cropping system is corn and soybeans. Through a variety of educational programs and outreach events we provide technical assistance to land owners/operators interested in other crop opportunities. Examples of 3rd crops include alfalfa, hazelnuts, grapes, wheat, oats, native grasses for seed or bio-energy uses. Examples of outreach include 3rd Crop Walk-N-Talks [field days]; 3rd Crop Winter Series [four day long workshops in Feb. and March]; on farm demonstrations; presentations; displays and news articles.

MADELIA MODEL is a regional community development project to demonstrate how sustainable renewable energy can serve as a catalyst to create jobs, add value to local produce and serve as a driver for a stronger community and sense of place. We are working with multiple partners to to build and demonstrate how this model would work in a rural community.

Martin County Farm2Cafeteria Network is a program we started in 2010. We had been working with local vegetable growers through our 3rd Crop Initiative and developed this program to increase consumption of local foods by local citizens and cafeterias in the county.
