During calendar year 2010, our Business Expansion and Retention Project visited 838 companies in our area, and provided help and referrals to assistance 403 times. This effort provided direct cash benefits to the businesses of \$243,347 with an increase of company revenues reported by the business of \$3,351,000. The companies leveraged \$2,796,007 in private investment in new plant and equipment with an additional \$170,290 of local revolving loan funds. Report cost savings to the companies is reported by them to be \$31,050. The companies reported 50 jobs created and 10 jobs retained.

The Children's Justice Center recently expanded into a new facility. The program provides a safe environment and temporary housing for abused women and children. It also provides other essential resources such as counseling, clothing, food, etc. There was \$24,270 raised for furnishings and equipment all of which directly benefited the Center with no overhead or expenses.
