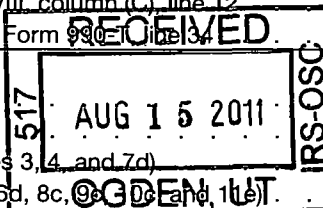

Client contacts for domestic violence services in 2010 include 1844 hotline contacts, 1182 DV group contacts, 2085 prevention education contacts, and 2348 individual contacts for support and legal advocacy.

SEXUAL ASSAULT - Services include crisis intervention, medical and legal advocacy, adult and adolescent support groups, and information and referrals.
