The programs are located in Brewster, Bridgeport, East Wenatchee, Moxee, Parker/Wapato, Prosser, Sunnyside, Tieton, Toppenish, Union Gap and Yakima.

The Children, Youth and Family Services division serves children ages birth through 5 years in the Medicaid Treatment Child Care (MTCC) program, The Crisis Nursery and Project Safe Care.
