Food Bank: Food distribution is every Saturday, Wednesday and Thursday. The Food Bank provided food for 76,242 individual feedings. Also the Food Bank distributed a limited number of free bus tickets to clients who need to use the bus to get to and from the Food Bank. During the year the Food Bank began home delivery for approximately 36 clients who are physically unable to travel to the Food Bank.

Emergency Service: Operates three days a week with three and a half hour shifts. Provides assistance to prevent evictions and utility shutoffs. Also provided free bus tickets, hygiene supplies, sanitary supplies, diapers, laundry detergent, rental move in funds and referrals to other agencies. There were approximately 4,900 client visits.
