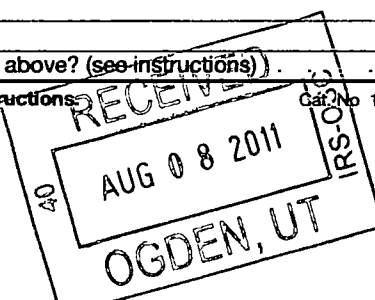

Transitional Housing is a 24 month housing and case management program for families with children. The intended outcome for this program is to assist families in moving from homelessness to stability through finding and retaining permanent housing.

In 2010, KITH served 30 families (90 individuals) in this program.

4b (Code:) (Expenses \$ \$168,300 including grants of \$) (Revenue \$)**Permanent**

KITH operates permanent housing for those who are previously homeless and/or at risk of homelessness. Rent is based on 28% of the tenant's gross income with a deduction for utilities. Salisbury Court has 12 units and Petter Court has 4 units. Case Management is provided when tenants are in need of that service.

In 2010, KITH served 16 families (39 individuals) in this program.

KITH provides resource and referral information for those facing a housing crisis. In 2010, over 500 households contacted KITH seeking housing help and most were given information about other community resources.

Community Supper is a weekly meal program sponsored by KITH. In 2010, approximately 2500 hot and nutritious meals were served to homeless and low income people in the area.

43 households received Thanksgiving food baskets

70 households received holiday food and gifts
