* Redesigned and expanded SPF's popular Crop Identification Sign program. SPF worked with community members to re-design and re-engineer the popular signs to make it easier for volunteers to transport and change out, as crops rotate around the valley.

The redesign makes use of standard "off the shelf materials" in order to make installation and replacement easy and efficient. Volunteers helped expand the program to cover more fields on existing routes.

* Launched Talking Fields in collaboration with WSU's Northwestern Research & Extension Center. Talking fields is a new and innovative program, using a system of low-power radio transmitters and web based "QR" technology for smart phones, to broadcast detailed information about the history and significance of Skagit Valley farms and Skagit Valley's culture of farming. The program is aimed at strengthening and enhancing SPF's efforts to inform the public about the importance of local agriculture and expand our capacity to protect Skagit Valley farmland from conversion to non-agricultural uses.

* Expanded SPF's Farm Tour Program. In response to popular demand, in 2010 SPF added a second farm tour (Summer Farm Tour) to our education and outreach programming, effectively doubling the number of individuals that are able to learn what makes the Skagit Valley one of the most unique agricultural valleys in the world, through a "behind the scenes" look at the critical important infrastructure necessary to sustain its longevity and viability.

* 61 New members join SPF. In 2010, through SPF's Farm Tour Program and community education programs, 61 new members joined SPF.

* Established SPF Investment Policy. In response to events that lead to the economic recession, the Board of Directors established SPF's Investment Policy to ensure SPF's reserves are invested in secure investment instruments.

* New Board Member. In July 2010, Dr. Stephen Jones, Director of WSU's Northwestern Research & Extension Center, was voted onto SPF's Board of Directors. Dr. Jones replaced outgoing Board of Director Debra Inglis, who retired from the board in June of 2010.
