WE ALSO SERVED 500,000 MEALS TO THOSE IN NEED, AND ALSO LAID THE GROUNDWORK FOR A SENIOR MEALS PROGRAM AND A NUTRITION EDUCATION PROGRAM IN ACCORDANCE WITH A GRANT FROM THE USDA, BOTH OF WHICH LAUNCHED AT THE VERY END OF THE YEAR.
