Columbia River Habitat Protection & Restoration CRK uses grass roots education, organizing, coalition building, and enforcement of state and federal laws to help protect key habitats along the Columbia River For example, in 2010, CRK utilized sampling probes and temperature loggers to understand key refuges for salmon, and provided the temperature data to Oregon and Washington agencies to help guide management decisions In addition, CRK worked to protect salmon nurseries in the Columbia River estuary from harmful dredging and wetland fill associated with two proposed Liquefied Natural Gas (LNG) terminals and their associated pipelines. CRK helped organize a large and diverse coalition of people fighting to protect salmon habitat, forests and farms In 2010, we protected a key Chinook salmon nursery by defeating the Bradwood Landing LNG terminal In 2010, CRK continued to work to protect salmon habitat and traditional fishing grounds from the Oregon LNG terminal proposed in Warrenton CRK also worked with citizens in Longview, WA to oppose a proposed coal export terminal, which was designed to be one of the largest coal terminals in the United States CRK worked with local citizen groups and clean energy advocates to propose better solutions than dirty coal

Restore Basic River Rights. The goal of the Basic River Rights program is to restore the public trust rights so people can catch and eat fish and swim with their families in the Columbia River without fear of toxic pollution CRK uses science-based advocacy, grass roots organizing, and legal enforcement of environmental laws to work toward this goal CRK works with state & federal agencies to strengthen water quality laws, which protect human health and aquatic habitat. In 2010, CRK was a member of the Oregon Fish Consumption Rulemaking working with the Confederated Tribes of the Umatilla Indian Reservation and others, CRK advocated that water quality standards must reduce toxic pollution to protect people who regularly consume fish Riverkeeper is a key voice speaking about the need to reduce toxic pollution in order to make fish safer to eat
In 2010, CRK also participated in the U.S. Environmental Protection Agency's Columbia River Toxics Reduction Workgroup, which includes stakeholders from businesses, organizations, and local, state, and federal governments. CRK provided regular updates on our work and contributed to a toxics reduction workplan for the Columbia River CRK provides a link between the educational goals of government agencies and the people that we serve CRK also advocates for the thorough clean up of the Hanford Nuclear

River Communities Project. Provides tools for local citizens to monitor water quality and habitat health in their communities along the Columbia River and its tributaries This Project includes the largest and most comprehensive citizen water quality monitoring program in the Pacific Northwest Our program cultivates stewardship by providing a hands-on activity that creates tangible river benefits. After learning about and caring for a river stretch in their community, our volunteers become active local voices working to better their waterways and their communities. The Project serves over 150 volunteers at 120 sites. CRK utilized the River Communities Project to advocate for more protective water quality standards, less toxic pollution in salmon, and clean and healthy swimming and recreational areas. The Project includes
1 Adopt-A-River CRK recruits volunteers to adopt a section of the Columbia or a local tributary, and work to protect and restore it. Volunteers receive training from CRK staff in how to identify plants, wildlife, water quality, and threats to their section. Volunteers regularly report on their adopted section and identify necessary restoration, which CRK then implements In addition, CRK regularly makes presentations in schools in Washington and Oregon Over the last three years, we have taught over 1800 school children and numerous classrooms have adopted their own stretch of river. We serve students in elementary, middle, and high school,

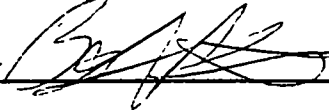
