The main focus of Esperanza's program is microcredit, providing small loans to the very poor. Microcredit - a small loan averaging \$150 to start or expand the small business of a person living in poverty. This capital empowers the working poor with self-employment so they can invest in their business and use the profits to provide for the basic needs of their families. Esperanza services people who are not eligible for commercial loans or who are preyed upon by loan sharks who charge extreme interest rates. Esperanza charges 2% interest on the loan balance, which is paid every two weeks over a six month period. Being in charge of their own business and working to repay the loan by their own merit fosters dignity and self-worth. During 2010 Esperanza reached over 70,000 people through Microcredit and provided more than 14,000 loans.
