RESEARCH, ISSUE EDUCATION & OUTREACH- AJS supported community organizations in their efforts to educate the public about access to health care, racial equity in health, budget equity, living wage jobs, and other issues related to economic and racial justice. To support these efforts, we produced and distributed the following research reports: Searching for Work that Pays: 2010 Job Gap study, Race Matters: Living Wage Jobs in the Current Economy; Native Health Underfunded & Promises Unfulfilled; Rules of the Road, Regulating Insurance Companies Is a Critical Component of Reform; and, Opening the Door: The Importance of Language and Literacy Access under Health Reform. We distributed our reports on our website, at public events & community forums, at press release events, and other methods. In addition, we continued to coordinate a 37-organization network (Health Rights Organizing Project) and assisted state-based groups with their economic and racial justice campaigns. We also used our immigration system board game in public education events. In 2010 the board game was downloaded independently by users in states as diverse as Arizona, California, Colorado, District of Columbia, Idaho, Massachusetts, Missouri, Nebraska, New Mexico, Oregon, Pennsylvania, South Carolina, Texas and Washington

MAIN STREET ALLIANCE NETWORK- AJS supported small business coalitions in 15 states across the Main Street Alliance network, reaching out to over 15,000 small business owners, providing educational opportunities to over 1,500 business owners, and engaging small business owners in over 80 public education events. AJS coordinated a survey of 1,237 small business owners in 13 states and released the findings in a research report, Main Street Policy Pulse: Small Business Views on Financial Reform, educating the public about small business owners' experiences in the economic recession. AJS provided opportunities for MSA small business owners to network across a national network in events and activities on health care, jobs, clean energy, responsible taxes, and immigration reform. AJS further provided staff training, strategic planning support, and on-the-ground organizing support to partners in the MSA network.

TRAINING & ORGANIZATIONAL DEVELOPMENT- AJS held more than 25 trainings/workshops/educational forums attended by over 750 participants. Leaders and staff from more than 35 organizations nationwide participated in these trainings. They included skills trainings (public speaking, community organizing, etc), issue trainings on topics ranging from racial disparities in health to banks' role in the recession, and supervision and time management. Events included two sessions of a new training initiative, the Justice Leadership Academy, to develop the skills and political analysis of a core set of community leaders from six states. AJS also invested significant resources in developing our affiliates' and partners' management skills. AJS held a financial management training for 12 administrative staff and board members from partner organizations. Through the Institute for Pragmatic Practice, AJS created a network of key thinkers, including organizers, researchers and policy makers, to generate innovative ideas for social change. IPP's first symposium addressed the intersections between campaigns for budget equity and for bank accountability. The Southside Commons, the AJS community center, hosted an eleven part film series and sponsored five workshops on topics ranging from Street Theater and Storytelling, to "A Black & Brown Discussion on the Economy" and "Campaigning in a Digital Age". In addition, Southside Commons was made available to other Seattle based non-profits who held over 167 events
