SAKYA FOUNDATION WAS FOUNDED WITH THE VISION OF PRESERVING TIBETAN BUDDHISM AND TIBETAN CULTURE AND THE SAKYA LINEAGE. THE ORGANIZATION OCCASIONALLY TRANSFERS FUNDS TO "SISTER" SAKYA ORGANIZATIONS (MANY OF WHICH ARE RECOGNIZED/ACKNOWLEDGED AS BEING RELIGIOUS ORGANIZATIONS). THE ORGANIZATION INTERNALLY IDENTIFIES SISTER SITES WHICH NEED FINANCIAL SUPPORT. THIS USUALLY IS COMMUNICATED IN PERSON, BY MAIL, OR E-MAIL. THE SAKYA BOARD DISCUSSES THESE GRANTS NEEDS. ONCE GRANTS ARE APPROVED, RECIPIENT ORGANIZATION MUST SIGN AND RETURN LETTER OF ACKNOWLEDGMENT STATING THE TERMS OF GRANT AND RESPONSIBILITY FOR COMPLIANCE WITH USE OF FUNDS. A BUDGET IS PREPARED IN ADVANCE OF ALL INTERNATIONAL WORK. LOCAL ORGANIZATIONS RECEIVING FUNDS FROM SAKYA PROVIDE ONGOING REPORTS. EXPENDITURES ARE MADE AGAINST BUDGETED AMOUNTS AND ANALYZED CONTINUOUSLY BY US-BASED MANAGEMENT. DISCUSSIONS, E-MAILS, AND OTHER TECHNIQUES OF COMMUNICATION ARE EMPLOYED TO ENSURE THAT FUNDS ARE UTILIZED ACCORDING TO THE ORIGINAL INTENT.
