Distributions to, or on behalf of Providence Benedictine Nursing Center for operations Since 1955, Providence Benedictine Nursing Center has been a model of excellence, innovation and best practices that include spiritual and emotional support in addition to physical care. The center has been a pioneer in caring for the frail and elderly in a variety of settings, always emphasizing the importance of an environment in which their individuality and preferences are respected. Today, doctors throughout the region refer their patients to our facility and home health services knowing we offer the most skilled and loving care possible. Providence Benedictine Nursing Center continues to be a leader in long-term care because we constantly challenge ourselves to review and improve our services. Recently, this has resulted in the creation of our therapy garden. This beautiful courtyard is filled with color, texture and fragrance, becoming a favorite spot for our residents and their families to relax. It is Providence's Mission to help all who need it, regardless of their ability to pay. More than half our residents and patients are Medicaid-eligible, while some of our counterparts do not even take Medicaid. Over the past decade, the need for our services has increased, but government reimbursement has continually decreased. The nature of the long-term care industry and the fluctuations in government funding continue to present challenges as we strive to maintain a quality of care that exceeds industry standards. It is through the generosity of donors that Providence Benedictine continues to be a leader in caring for the elderly and physically fragile. Funding was provided by Providence Benedictine Nursing Center Foundation for the continuation of our Choice Menu program. This included replacing our dishes with new colorful dishes because studies show they will improve appetites. The insulated domes and bases we use for keeping food hot and cold were failing and these were replaced. A new piano was purchased to replace our old well used, but worn out, one. The Pastoral program was given funds to replace chalices, albs, and other supplies as well as purchasing Bibles. The PBNC Child Development Center, which allows for intergenerational activities, was able to install a covered play area so that the 35 children could enjoy the outside during inclement weather using Foundation funds. Scholarship monies were provided so families who could not afford the childcare could make use of our nationally accredited center.

Providence is one of the larger health systems in the country, and as such, the Board benchmarks executive compensation against other large, not-for-profit health systems whose revenue is similar to that of Providence. Base salaries for Providence executives are set at the median level of the market, as identified by the independent consultant and reviewed with the Human Resources Committee.</p> <p>Performance incentives allow executives to earn additional compensation if they achieve specific organizational and individual goals for furthering Providence operating principles - advancing the Providence Mission and core values, meeting benchmarks for charity care, achieving quality targets, delivering top-rated customer satisfaction, meeting employee satisfaction goals and reaching financial performance objectives. The Board of Directors conducts a thorough process to ensure performance incentives are aligned with appropriate practices for not-for-profit health care systems. The Board's process for executive compensation fully complies with IRS standards and mirrors the best practices recommended in the "Report to Congress and the Nonprofit Sector on Governance, Transparency, and Accountability" submitted to the Senate Finance Committee by the Panel on the Nonprofit Sector. The Foundation Executive Director is compensated by a related organization which uses a market based compensation program utilizing several independent third party compensation market surveys to establish pay ranges for the position. The related organization then establishes the individual rate of pay within the range based on relevant experience, skills and competencies. The rate offered to the Executive Director at the time of hire was determined through discussion between the Regional CEO, Regional Director of HR and the Administrative Director of HR. The ranges and rate of pay are reviewed on an annual basis by Regional HR.</p>
