Support of the Northwest Weather and Avalanche Center (NWAC). Continued the development of a combined NWAC and FOAC website with improved user-access to avalanche hazard forecasts, weather station data, education resources, and user provided information on snowpack, accidents, and photos. Had approximately 499,000 unique public visits and approximately 38.7 million web pages viewed by the public on the FOAC/NWAC website in 2010.

Conducted two major fundraising events in support of NWAC with 550 participants that raised revenue and awareness of the programs offered.

Public education. Conducted 26 Avalanche Awareness presentations to user groups at retail stores, agencies and organizations reaching over 800 participants in the states of Oregon and Washington. Funds were spent developing, updating and printing signs, brochures and other informational materials, including 400 awareness signs installed as Washington and Oregon Sno-Parks and trailheads. Provided funding for four snowmobile safety instructors to receive advanced training from the American Institute for Avalanche Research and Education (AIRE). These instructors, in turn, conducted three training courses. Provided funding for the 2010 Northwest Snow Avalanche Summit (NSAS) reaching 200 professional and recreational participants. Participated in the Puyallup Snowmobile Expo reaching over 600 people with our awareness message. Funded a Youth Education Survey that helped define our youth education strategy moving forward. Initiated a Pilot Youth Education effort in the Greater Seattle area. Presented our survey results at the International Snow Science Workshop.
