MEDRIX sponsorship for nursing assessment and nursing standards training at Hue Central Hospital:
MEDRIX sent 4 U.S. nursing professionals to Hue, Vietnam to train doctors, nurses, and midwives at Hue Central Hospital in nursing assessment and nursing standards. Three of the nursing professionals trained doctors, nurses, and midwives at Hue Central Hospital how to more accurately assess a given patients' diagnosis. This enables the doctor, nurse, or midwife to properly treat the case the first time. The fourth nursing professional trained doctors, nurses, and midwives higher nursing standards at Hue Central Hospital. These nursing standards equip doctors, nurses, and midwives at Hue Central Hospital to implement nursing standards that will improve the general healthcare provided by the hospital.

Medical Training & Development through International Exchange:
MEDRIX sponsored 10 Seattle Pacific University nursing students and partnered with 10 Hue Medical and Pharmacy School of Nursing students and Hue Central Hospital for an International Education and Training program in Pediatric Clinical Training and Community Health in Vietnam. The participants taught in 1 pediatric hospital, 1 community hospital, 4 village health clinics, pre- and elementary schools, middle school and participated in home visits. Over 500 Vietnamese women received education in personal health & hygiene, environmental health, and cleanliness during pregnancy from the Seattle Pacific University nursing students.

Medical Training through Integrated Management of Childhood Illnesses (IMCI) & Medical Terminology:
MEDRIX provided IMCI training for 33 doctors, nurses, and midwives in Central Vietnam. The program seeks to improve health, specifically with children, in communities throughout Vietnam through this training. The attendees learn to detect childhood illnesses at earlier stages and therefore improve the health of the children in their respective communities. The net affect of training 33 doctors, nurses, and midwives will affect 66,000 Vietnamese citizens with better health care services. In addition to IMCI training, MEDRIX sponsored the training of Medical Terminology. Each participant received a medical terminology textbook for their use in their respective health clinics.

• MEDRIX evaluated and funded seven heart surgeries for Vietnamese children at Hue Central Hospital in Hue, Vietnam that will extend each of their lives.

• MEDRIX continued to sponsor the development and maintenance of ultraviolet water systems in the Hue Province of Vietnam. The maintenance of 60+ systems is performed by Vietnamese nationals that are sponsored by MEDRIX. The water systems are located in highly populated areas such as schools, health clinics, etc. The systems provide safe drinking water through ultraviolet water filtration.

• MEDRIX also provided sponsorship to the Ho Chi Minh City Psychiatric Hospital for the doctors to receive additional training in the field of Autism. In addition, MEDRIX provided 2 U.S. professionals to train the doctors/employees of the Psychiatric Hospital how to correctly diagnosis and manage treatment for an Autistic patient.
