Our mission is inspired by our recognition that every human being, created in the image of God, is uniquely precious and worthy of dignity, and we aspire to respond fully to God's command "Justice, justice shall you pursue." The vision we seek to achieve is a California with a moral economy - a California in which all workers earn a sustainable wage, labor in just working conditions, live with an assurance of racial and gender equality, have affordable access to quality health care, and enjoy a powerful voice in the decisions that affect their lives. We work to realize our vision by organizing religious leaders and congregations of all faith traditions to support and empower low-wage workers in their struggles for dignity. Our primary mission partners are low-wage workers, the labor and community organizations that support them, and God.

During 2010, the organization continued achieving its goals of building the capacity of its local affiliates, collaborating on statewide campaigns, seeding new groups in strategically important areas and providing technical assistance to small emerging interfaith groups. CLUE clergy and laity leaders have carried out letters and delegations to management, drawn public attention to workers' concerns and struggles through creative faith-rooted public events and provided emotional and spiritual support to workers so that they could sustain their struggle for justice. The organization has also educated congregations about the moral implications of public policy issues and trained congregation members to engage in civic participation activities. As a result, thousands of low-wage workers and their families have made significant progress towards the goals of living wages, affordable health insurance and improved working conditions. The organization is also developing special faith-rooted educational materials and has carried out educational presentations across the state about the moral implications of public policy including healthcare reform, workers rights legislation and immigration.
