EARLY CHILDHOOD EDUCATION - Early Childhood Education includes the Head Start, Early Head Start, Care4Kids and School Readiness programs which are operated in collaboration with the City of Danbury Public School System. Major funding is through the U.S. Department of Health and Human Services (DHHS), State of Connecticut Department of Social Services (DSS) and Department of Education (SDE). CIFIC provides Head Start preschool and infant/toddler education services to low and moderate income Northern Fairfield County residents. In addition, CIFIC serves special needs children referred by other local and state agencies.
