They then have a formula that they apply to the results to assist in their determination of the GM's compensation.

Part VI, Line 15b - The General Manager annually does a survey of 16 electric utilities in the northwest of comparable size for management staff. The GM then evaluates results with compensation given to GM by the board and compensation that supervised staff is getting from their wage & salary program to determine compensation for management staff.
