The events promoted running and walking for fitness, fun, health and overall quality of life. The smallest of the events drew approximately 100 participants and the largest event had 3,200 participants.

The organization produced a newsletter monthly that was distributed over the internet and by emails, and a written publication once every other month, The Oregon Distance Runner, in 2010. The newsletter and printed publication highlight events that people can participate in, have health and nutrition information, articles on running, walking, road racing and fitness.
