 The Klamath-Siskiyou Wildlands Center (KS Wild) is an advocate for the forests, waters and wildlife of the Klamath and Rogue Basins of northwest California and southwest Oregon. We use environmental law, science, collaboration and education to defend healthy ecosystems and help build sustainable communities.

 KS Wild's Conservation Program is designed to fulfill the group's mission to protect and restore the biological diversity of the Klamath-Siskiyou region. This area, stretching roughly from Roseburg, Oregon in the north to Redding, California in the south, and from the Pacific Ocean to the Cascade crest, contains some of the most ecologically critical wildlands along the entire West coast of the continental U.S. Our focus is more than 8 million acres of federal public lands in this region administered by the National Forest Service and the Bureau of Land Management (BLM), including the Medford and Klamath Falls Districts of the BLM, and the Six Rivers, Shasta-Trinity, Rogue River-Siskiyou and Fremont-Winema National Forests. The Conservation Program was created in response to a history of ecologically destructive land management practices, including widespread clearcutting of old-growth forests, road building, cattle grazing and suppression of natural fire regimes. The core of this effort is our Forest Watch program, which monitors every proposed federal land management project in our geographic area of focus. We participate in the public planning process articulated in the National Environmental Policy Act (NEPA) through comments, appeals and litigation, when necessary, against projects that pose a threat to forest health and biological diversity. We "groundtruth" proposals and projects to ensure compliance with environmental laws, and provide relevant information to the public and decision-makers.
- 4b** (Code: _____) (Expenses \$ 56,612 including grants of \$ 6,416) (Revenue \$ _____)
 KS Wild's Forest Watch work is primarily a defensive approach to wildlands conservation. A more proactive approach is embodied in a variety of local, regional and national Campaigns that join KS Wild with other groups and networks to address a range of issues, including protection of threatened and endangered species, achieving designated Wilderness status for roadless areas, and promoting sustainable strategies to reduce the threat of catastrophic wildfire in the wildlands/urban interface zone. Campaigns and networking enhance our impact and bring national attention to these issues. Among many other ongoing projects that are part of the Campaign sector of our Conservation Program, KS Wild is involved in the BLM's Pilot Project in the Applegate Valley of southern Oregon, which is a collaborative approach among a wide range of stakeholders to create a model of sustainable management that would allow the BLM to move forward with thinning of small-diameter trees in crowded, second-growth stands with broad community support. Habitat restoration is a critical component in our Campaign work. In October of 2010 we released a detailed report that creates a roadmap for the future, titled "Restoring the Rogue: A Plan to Prioritize Restoration on Federal Lands in the Rogue River Basin." The plan outlines priorities and opportunities for effective habitat restoration on public lands, thereby better informing collaboration and encouraging the most effective use of scarce resources to enhance fish and wildlife habitat while creating new jobs.
- 4c** (Code _____) (Expenses \$ 112,087 including grants of \$ _____) (Revenue \$ 424)
 The third critical element of KS Wild's Conservation Program is Outreach. We work to educate the public about the value of intact, healthy ecosystems and the long-term ecological and economic consequences of federal land management practices, including timber sales, road construction, predator control, mining, public lands grazing and recreational developments. In order to fulfill these goals we produce and distribute a quarterly print newsletter (3,500 copies per issue) and bimonthly email updates, lead hikes, show environmental films, and coordinate a variety of educational public events. KS Wild's growing membership, currently near 1,800 paid members, has become a stronger voice for conservation and wise public lands stewardship. Our outreach efforts complement KS Wild's conservation advocacy by building a strong constituency for wildlands protection and restoration in the Klamath-Siskiyou ecoregion. By leading regular hikes and outings, we have brought hundreds of area residents to a deeper understanding of the variety and beauty of the area's natural environment, acquainting them with the unique plant and animal species, wild rivers, towering forests, and sweeping mountain vistas that make the Klamath-Siskiyou region one of the most important refuges for wild nature in the United States.

One of the primary goals of KS Wild's Conservation Program is habitat restoration on public lands. In service of this goal, we have been pursuing for several years the permanent retirement of certain public lands grazing allotments that that have allowed private individuals to turn cattle loose for grazing on public lands. This program has historically benefited a limited number of individuals while causing extensive degradation of public lands, to the detriment of taxpayers, other public lands users, wildlife, and native vegetation. After extensive negotiations and Congressional approval, we have been moving forward with a plan to retire one of these allotments on the Rogue River-Siskiyou National Forest. The payment of \$6,416 listed above was made to a local rancher in southern Oregon in order to achieve this goal. The payment was not a "grant" in the usual sense, but a payment to compensate this individual for current and future lost income, and was made with funds raised from concerned citizens who support this goal. No public or government funds were used for this payment.

Form 990, Part III Statement of Program Service Accomplishments

The most recent addition to KS Wild's efforts to protect the environment of the Klamath-Siskiyou region is the Rogue Riverkeeper program. Launched in 1999, Rogue Riverkeeper, a member of the Waterkeeper Alliance, expands our work to focus on aquatic habitat issues in the Rogue River watershed and adjacent coastal watersheds. Through enforcement of the Clean Water Act and other environmental laws, Rogue Riverkeeper works to ensure that our nation's water quality laws are not ignored. There are many activities that threaten water quality and the health of aquatic habitats, including suction dredge gold mining, gravel mining, inappropriate streamside development projects, urban stormwater management, bacterial pollution, agricultural runoff, dam construction, and excessive irrigation diversions. Rogue Riverkeeper is working to address these and other issues through education, collaboration, legal action, and coordinating an extensive network of volunteer supporters to collect data that enhances our understanding of where these problems are most severe. We worked to build public support for the removal of Gold Ray Dam on the Rogue River, thus removing the final impediment to a free-flowing river from Lost Creek Dam to the Pacific Ocean, helping to ensure the continued survival of threatened populations of Coho and Chinook salmon, steelhead, Pacific lamprey, and many other species that depend on natural flows of cool, clean water. Rogue Riverkeeper is also working to ensure long-term protection of the Rogue and Chetco Rivers through the provisions of the Wild and Scenic Rivers Act.
