SAFETY & SENTENCING- Our Safety & Sentencing program develops approaches to public safety that more effectively build safe communities, are fiscally responsible, and reduce our reliance on incarceration. The program promotes safe and sensible sentencing reform as well as alternatives to incarceration. PSJ has historically worked to challenge the way youth are treated as adults within Oregon's criminal justice system; and in 2010 this work coalesced into the launch of our Safe Kids, Safer Communities Campaign. The initial campaign goal is to keep kids out of adult jails. Currently in Oregon, the default placement for youth charged as adults while awaiting trial is adult jail. PSJ seeks to change the default placement to a juvenile detention center. Juvenile facilities are better equipped to provide youth charged with crimes the education and treatment services to which they are entitled. Juvenile facilities also decrease the risk of assault and suicide, which are higher for youth held in adult jails. Finally, numerous studies have found that youth placed into the adult criminal justice system are more likely to commit future crimes. Studies by the Centers for Disease Control and the Office of Juvenile Justice and Delinquency Prevention concluded that transfer of juveniles to the adult system increases recidivism for youth.

We are in the first year of a 3 year campaign to move Oregon away from the criminalization of addiction toward (cont. on Sched. O)

MEMBERSHIP ENGAGEMENT- The focus of our membership engagement program work is to position PSJ as a leader for facts and analysis on the need for reforming the criminal justice system and increase our member involvement in that reform. Through Justice Matters, our news journal, we reached over 5,000 people each issue with news, issue analysis and resource information. In 2010 we covered topics such as racial inequity in Oregon, rethinking public safety spending strategies, and how money matters to survivors of domestic violence. We sent out 4 electronic action alerts to over 1,000 members of our Action Alert Network encouraging them to become more involved in reforming the criminal justice system. We had 30,678 visitors to our website, including 210 Google Ad clicks to our website, which continues to inform people on criminal justice issues. In 2010 we also launched a Facebook page, which was "liked" by 403 people.

CRIME SURVIVORS PROGRAM- Our Crime Survivors program builds the voice of survivors of crime and violence to promote progressive responses to the needs of survivors, and support criminal justice reform that reduces future violence. In 2010, we continued to develop our holistic, multi-constituency approach working in coalition to strengthen support services and funding for crime survivors. This is not only an area where our advocacy can have the most beneficial and tangible impact for crime survivors, it is also an area critical for us to deepen valuable relationships in the field. We continued work on the Crime Survivors' Toolkit. The "tools" consist of comprehensive, easy to understand, culturally competent booklets that address a variety of victimization aspects and issues including domestic violence, sexual assault, stalking, homicide, and adult survivors of child abuse, and more general topics like Responses that People Commonly Experience After Crime and How to Find Help in Your Community. This material will fill a gap in needed resources, and will be produced in written form for distribution and also be available on our website.
