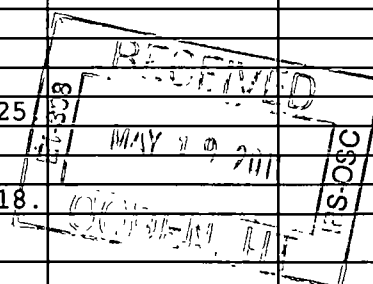

The Horstkotte Family Charitable Foundation has been engaged in the support of programs benefiting handicapped youth. In addition to this charitable activity, the Board of Directors of the Foundation is engaging in other charitable activities as follows:

- 1) The support of institutions that provide care and services to children, especially orphans and children with emotional difficulties, both at home and overseas. In foreign countries, the Horstkotte Family Charitable Foundation makes grants to humanitarian, 501(c)(3) organizations that help children in developing countries to alleviate poverty and provide basic necessities such as food, water, medical care and shelter. The Foundation supports organizations that provide disaster relief as well as those seeking to address the symptoms and underlying causes of chronic poverty.
- 2) Grants to public and nonprofit schools, art museums and cultural institutions that advance learning and appreciation of the wide range of human creativity and knowledge.
- 3) Grants to religious activities and organizations, and to a broad range of charitable organizations with 501(c)(3) status that promote, protect and provide opportunities for spiritual or personal growth and public service.

4) Grants for work protecting the environment, advancing environmental justice, and supporting activities grounded in an environmentalist ethic such as creating gardens and preventing cruelty to animals.

5) Grants to support health programs that educate the general public about specific diseases and promote research on cures for diseases.
