BYLAWS
of
ROGUE BASIN COORDINATING COUNCIL, INC.

ARTICLE I. NAME

The name of this Corporation is Rogue Basin Coordinating Council, Inc. (RBCC).

ARTICLE II. OFFICES

The Corporation shall maintain in the state of Oregon a registered office and a registered agent located at the registered office. The RBCC may at any time, in accordance with Article VIII change the location of the registered office and the person designated as the registered agent. The Corporation may also have other offices at such places as the RBCC may fix by resolution.

ARTICLE III. PURPOSE

This Corporation shall be organized and operated exclusively for public benefit and educational purposes. Subject to the limitations stated in the Articles of Incorporation, the purpose of the Corporation shall be to engage in lawful activities, none of which are for profit, for which corporations may be organized under Chapter 65 of the Oregon Revised Statutes and Section 501(c)(3) of the Internal Revenue Code of 1954, or their corresponding future statutes.

ARTICLE IV. MEMBERSHIP

Section 1. Each sanctioned watershed council within the Rogue River Basin shall be eligible for voluntary membership in the RBCC. Sanctioned watershed councils are defined as state sanctioned or county recognized watershed councils.

Section 2. Each member watershed council shall select an RBCC Director and alternates and submit written verification of those selections to the RBCC at each Annual Meeting.

Section 3. Any vacancies on the RBCC will be filled by that member watershed council. Written verification of its selected Director and/or alternates shall be submitted to the RBCC at or prior to the next regularly scheduled RBCC meeting.

Section 4. New membership will require amendment of the bylaws in accordance with Article XV.

ARTICLE V. BOARD OF DIRECTORS

Section 1. The RBCC Board of Directors shall manage the affairs of the corporation.

Section 2. The number of Directors shall be equal to the number of RBCC member watershed councils and there shall be one Director from each RBCC member watershed council.

Section 3. The Board of Directors may elect or appoint other officers and agents, and hire employees, as it shall deem necessary and desirable. The other officers, agents and employees shall hold offices for such terms and have such authority and perform such duties as shall be determined by the Board of Directors.

Section 4. The Board of Directors shall serve without compensation from RBCC.

ARTICLE VI. OFFICERS

Section 1. The officers of the Corporation shall be called President, Vice President, Treasurer, and Secretary.

Section 2. At each annual meeting, the Corporation shall elect said officers to serve one-year terms. An officer may be reelected without a limitation on the number of terms he/she may serve.

Section 3. A vacancy of an office shall be filled no later than the second regular meeting of the Board of Directors following the vacancy.

Section 4. The President shall chair all Board of Director meetings and shall see that all orders and resolutions of the RBCC are carried into effect.

Section 5. The Vice President shall chair Board of Director meetings in the event of the President's absence, and conduct other duties as may be assigned by the President.

Section 6. The Treasurer shall report the status of all corporate funds at every regular Board meeting.

Section 7. The Secretary shall have overall responsibility for corporate record keeping.

Section 8. No person shall occupy more than one office at any given time.

ARTICLE VII. MEETINGS

Section 1. The annual meeting of the RBCC shall be held on the 4th Monday of March in each calendar year.

Section 2. Regular and special meetings of the corporation shall be held at a time and place to be determined by the Board of Directors. Notice of regular meetings, to include the forthcoming agenda and minutes of the previous meeting, shall be delivered to each board member in writing not less than seven (7) calendar days prior to the meeting. Notice of special meetings shall be delivered to each board member verbally, in writing or electronically, not less than two (2) working days prior to the meeting, accompanied by an explanation of the need for a special meeting.

Section 3. A quorum is a majority of the number of Directors in office immediately before the meeting begins.

ARTICLE VIII. VOTING

Section 1. Each member watershed council is entitled to one vote on the RBCC. The RBCC Director shall be considered the primary board member from each member watershed council. In the event that the Director cannot attend a meeting, the selected alternate may then vote in place of the Director.

Section 2. Approval of any business action put before the RBCC requires a consensus minus one vote of Directors or alternates from all active watershed councils in attendance.

Section 3. Signed, written proxies will be accepted when counting votes for the actions specified by the proxies when extenuating circumstances occur as described in the RBCC minutes.

Section 4. Any action required by law to be taken at a meeting of the RBCC, or any action which may be taken at a RBCC meeting, may be taken without a meeting if consent in writing, setting forth the action to be taken, is signed by all the RBCC directors.

Section 5. Each sanctioned watershed council is considered active unless otherwise noted in these bylaws. A watershed council is termed inactive when its Director or alternate fails to attend three (3) consecutive meetings, or six (6) meetings during any twelve-month period. A council becomes reactivated upon attending a regularly scheduled RBCC meeting.

ARTICLE IX. COMMITTEES

The Board of Directors may establish such standing or ad hoc committees as it deems necessary and desirable. Such committees shall be advisory in nature. Committees need not be composed of members of the RBCC, but shall be approved by the RBCC Board of Directors.

ARTICLE X. AUTHORITY AND LIABILITY

No officer, committee, or director of the Corporation or other person shall contract or incur any debt on behalf of the Corporation or in any way render it liable unless authorized by the RBCC.

ARTICLE XI. CORPORATE OBLIGATIONS AND FUNDS

Section 1. Contracts. The Board of Directors has authority to enter into any contract or obligation on behalf of the Corporation. The Board of Directors may delegate this authority to any officer or agent, in addition to the officers expressly authorized by these bylaws, to enter into or execute and deliver any instrument in the name of and on behalf of the Corporation. Any such authority may be general or confined to specific instances. Such authority may only be granted in writing.

Section 2. Checks, Drafts, Promissory Notes, etc. All checks, drafts, orders for the payment of money, notes or other evidence of indebtedness issued in the name of the Corporation, shall be signed by such officers, agent or agents of the Corporation and in such a manner as shall from time to time be determined by resolution of the Board of Directors. In the absence of such determination by the Board of Directors such instrument shall be signed by any two of its officers: president, vice-president, secretary or treasurer.

Section 3. Deposits. All funds of the Corporation shall be deposited according to regular business practices to the credit of the Corporation in such banks as the Board of Directors may select. Except and unless authorized by the Board of Directors, all funds of the Corporation shall be deposited in an interest-bearing checking account. If corporate funds are to be invested otherwise, it will require an affirmative act of the Board of Directors.

Section 4. Gifts. The Board of Directors may accept on behalf of the Corporation any contribution, gift, bequest or donation for the general purpose or for any special purpose of the Corporation. The secretary and treasurer shall record an accounting for such gifts as required by their offices.

ARTICLE XII. BOOKS AND RECORDS

The Corporation shall keep at its registered or principal office, correct and complete books and records of accounts; minutes of the proceedings of its members, Board of Directors and all committees; and the names and addresses of the members entitled to vote. Upon request, any interested party may inspect all books and records of the Corporation.

ARTICLE XIII. FISCAL YEAR

The Corporation shall have a fiscal year beginning on the first day of January and ending on the last day of December of each year.

ARTICLE XIV. CONFLICT OF INTEREST FOR MEMBERS OF THE BOARD OF DIRECTORS

Section 1. Definition. Conflict of interest is defined as taking official action that may result in financial benefit or avoiding a negative financial effect on a Director, the Director's relative, or a business organization with which either is associated. -

Section 2. Public Announcement. If a Director of the Corporation is met with a potential or actual conflict of interest, that Director shall announce publicly the nature of the conflict and declare the conflict prior to discussion, recommendation, vote, or any action taken thereon in the capacity as a Director of the Corporation. Such conflict shall be recorded in the minutes of the Corporation.

Section 3. Participation. Individual Directors who have declared a potential conflict of interest may participate in discussions and recommendations, but may not vote or take any action thereon.

ARTICLE XV. AMENDMENTS TO BYLAWS

These bylaws may be amended or repealed and new bylaws adopted by the Board of Directors, only by a consensus minus one vote of all Directors then serving. A proposed amendment may be offered at a regular meeting but cannot be voted on until at least the following regular meeting of the Board of Directors.
