The Foundation invests in the next generation of California lawyers by awarding scholarships to outstanding law students and recent law school graduates who intend to pursue public interest law careers and to outstanding law students from communities underrepresented in the membership of the State Bar. In 2010, the Foundation awarded more than \$102,500 in Public Interest Scholarships to 23 students, \$34,000 in Rosenthal Bar Exam Scholarships to 12 students, and more than \$180,000 in Diversity Scholarships to 28 students.

4b (Code [REDACTED]) (Expenses \$ 275,043. including grants of \$ 236,248.) (Revenue \$)

The Foundation champions full and equal access to the justice system by providing financial support to nonprofit organizations, courts, the State Bar of California, and local, specialty, and minority bar associations. In 2010, the Foundation awarded \$236,248 in grants to law-related projects throughout California, with a special focus on funding projects supporting rural communities and language access projects.

The Foundation educates the public about its rights and responsibilities under the law through its support of the State Bar of California's public education publications. In 2010, the Foundation provided a \$65,000 grant to the State Bar to support the publication of Kids & the Law: An A-to-Z Guide for Parents, copies of which are provided free of charge to more than one million children, parents, caregivers, and others who work with children over three years.
