THE SUPPORT FROM HOSPITAL TO HOME FOR ELDERLY (SHHE) PROJECT IS AN INTERVENTION DESIGNED TO REDUCE UNNECESSARY HOSPITAL READMISSIONS FOR THE FULL RANGE OF SENIORS ADMITTED TO THE INTERNAL MEDICINE, CARDIOLOGY, FAMILY MEDICINE OR NEUROLOGY SERVICES AT SAN FRANCISCO GENERAL HOSPITAL & TRAUMA CENTER (SFGH). BEGUN INITIALLY AS A PILOT PROJECT, THE SHHE INTERVENTION WILL BE THE FIRST RANDOMIZED CONTROLLED TRIAL TO SPECIFICALLY ADDRESS THE MYRIAD OF CHALLENGES FACED BY NON-ENGLISH SPEAKING PATIENTS DURING THE TRANSITION FROM HOSPITAL TO PRIMARY CARE PROVIDER VISIT, A VULNERABLE TIME IN THEIR CARE.
