North American Pollinator Protection Campaign (www.NAPPC.org) is affiliated with over 120 organizations, working to implement promote and support a clear, continent-wide coordinated Action Plan to encourage activities that assure documented increases in numbers and health of both resident and migratory pollinating. The goal of the NAPPC Conference is to plan for significant NAPPC initiatives related to increased awareness and direct involvement in pollinator throughout North America by engaging the audiences that have the most potential to create positive gains for pollinators. These target protection audiences have been identified as Federal Public Land Managers, Farmers and Ranchers, Gardeners and Food Consumers, Utility and Transportation Rights of Way Managers, and Municipal Areas and Golf Course Superintendents. A few highlights of NAPPC accomplishments include (1) partnering with numerous government organizations influencing over 1.5 billion acres of U.S. land, (2) creation of pollinator-friendly ecoregional planting guides free to download on the Pollinator Partnership website, (3) The Ecoregional Guides are a series of 24 page, beautifully illustrated booklets describing all that is needed in each Ecoregion of the 35 Bailey's Ecosystem Provinces. Each guide has a different cover illustrating the farming and wildlife communities of the location. Each has a customized plant list for the Ecoregion, a list of bloom periods, and habitat hints. Specific instructions are given for farmers, public land managers and home gardeners. Also included are how-to checklists, background on pollinators of all types, resources for further investigation, and a request for feedback. Because the guides are online, we can update them and make additions as we receive feedback from users.

IABIN Pollinator Thematic Network - After a successful Dec. 2006 meeting in Indaiatuba, Brazil, where the group of experts discussed needs, addressed issues, and provided recommendations for developing a Pollinator Thematic Network for the Americas. Accomplishments include putting together and distributing of a questionnaire to better data resources, needs, priorities, and information gaps. Over 180 questionnaires have been completed.
