(Revenue \$)Re-grants to state affiliates:The next largest portion of our program expenses was distributed in support grants to state affiliates. State IPLs educated their congregations about global warming and advocated for clean energy alternatives to coal, advocated for renewable energy incentives, fuel standards, and caps on greenhouse gas emissions. We added five new state affiliates in 2010: Wisconsin, Indiana, South Carolina, New Hampshire, and Florida.4c (Code) (Expenses \$ 238,853. including grants of \$) (Revenue \$)California IPL:California Interfaith Power and Light educated its congregations about global warming and advocated for equitable and effective climate policies at the state level. CIPL also supported an increased renewable energy standard for utilities.
