PCH provides equipment, training, data & operational support to organizations and individual researchers seeking to improve the quality, robustness & accessibility of the internet. Current & ongoing PCH projects include the construction of internet exchange points (IXP's) throughout the developing world; support for globally distributed domain name systems (DNS) resources; implementation of network research data collection initiatives in more than 3 dozen countries and the development & presentation of educational materials to foster a better understanding of internet architectural principles and their policy implications among policy makers, technologists and the general public.

Voice over Internet Protocol Network Security. PCH is working to advance the utility of voice-over-IP (VoIP) in the construction of command and control networks for coordination of global critical infrastructure security and management, in both the specific case of INOC-DBA and for general application. PCH conducts research on issues faced by INOC-DBA as it evolves toward a critical command and control infrastructure tool and to undertake development of some core services to address already recognized needs. The tasks include strong cryptographic authentication of the system's users; high availability of the communications services; examination of the system's metadata for situational awareness & integration of the system with other communication service & technologies.

Routing Topology & Network Reliability Dataset Project. PCH assists the Department of Homeland Security in regularizing the publication of its existing internet routing topology archive, a large-scale BGP route dataset produced by global network of data collection nodes which we've been deploying since 1994 and by applying instrumentation to our INOC-DBA infrastructure protection hotline system enabling its rapidly growing collection of end-user telephony devices to perform end-to-end loss, latency & jitter measurements between thousands of critical sites across the commodity internet.
