We operate five Ronald McDonald Houses in Southern California in Bakersfield, Loma Linda, Los Angeles, Orange County and Pasadena In 2010, we served more than 15,000 people through the Ronald McDonald House program and provided more than 30,000 overnight stays for families with seriously ill children In addition, more than 98% of our families indicated their stay at a Ronald McDonald House had a positive impact on them and their child's recovery at a local pediatric hospital We also made remarkable progress in 2010 toward opening a new Ronald McDonald House in Long Beach
