Lido Isle Yacht Club Sr. Program Events
The Lido Isle Yacht Club sponsors events throughout the year for its community of almost 400 members. These events include the Taste of Lido, Commodore's Beach Party, Friday Night Racing & BBQs, Change of Watch and Electric Boat Parties.
The objective of these events is to provide activities for the members to drive membership, promote the community and create revenue used to fund the sailing and yachting activities of the club.

Lido Isle Junior Sailing Program
The Lido Isle Junior Sailing Program is sponsored by the Lido Isle Yacht Club to provide a 6-week program for sailing instruction and participation by junior members. There were 58 active junior sailors in 2010. Additionally there was a Fall sailing program in 2010 where 20 junior sailors participated in sailing activities on weekends for a period of 4 weeks.
Certified Sailing instructors are hired to teach sailing to the program participants for the term of the program. The Lido Isle Yacht Club maintains approx 15 chase boats and launches to support the sailing and racing activities of LIYC and the Jr. Sailing Program.
LIYC also holds a number of regattas in the harbor to host racing events attended by junior sailors of nearby yacht clubs and provides trophies for winners of such events.

Lido Isle Yacht Club hosts a number of yachting events throughout the year to promote sailing and racing activities throughout the community and for its members. Such events include Opening Day, Pre-Ensenada Race sponsored team send-off party, Lecture series, a CPR class, Friday Night Adult Sailing Races and membership in Sailing Associations.
Trophies are provided for winners of Adult Sailing Races.
