- Updated our flagship geographic information system used by 275 Christian ministries in 40 countries; and updated and enhanced our international geographic databases.
- Provided custom mapping services to a dozen international Christian ministries and created hundreds of maps for the new Operation World book.
- Enhanced our free online mapping service through the Mission InfoBank website.
