IT HELPED BUILD THE CAPACITY OF THESE SHELTERS BY TRAINING SHELTER STAFF TO DEVELOP AND LEAD WEEKLY ART WORKSHOPS THAT EXPLORE SPECIFIC THEMES IN HEALING FROM ABUSE, SUCH AS HANDLING ANGER, REBUILDING SELF-CONFIDENCE, AND LEARNING POSITIVE COPING SKILLS.
